



F2F Project – Letter for Associated Partners

Dear Sir/Madam,

The F2F project, co-financed by the Sixth Framework Programme for Research and Technological Development, aims at increasing the competitiveness of SMEs in the EU-MED fashion system through simplified access to world wide research & innovation results, and through enhancing the readiness of SMEs to participate in future European RTD programmes, above all FP7.

The main project activities include the collection of global research results, the development of a methodology for the analysis of failure/success stories in EU Framework Programmes, the organisation of several project ideas generation events, and the setup of a "project lab" to support SMEs in successful participation to future FP7 calls for proposals.

The project is being carried out by a consortium led by IPI – The Italian Institute for Industrial Promotion, and composed of 38 partners from European and Mediterranean Countries, including RTD performers, SMEs Innovation supporters and SMEs and Business associations (see attached summary).

The project structure was designed so as to foresee the collaboration of Associated Partners, i.e. partners external to the consortium set up at the beginning of the project, who could nevertheless benefit from the different project activities.
